Abstract: Subsequent to the publication of the following paper in *Avocetta*, the authors were made aware of an error in the dataset affecting the results presented in Table 4. After re-analysing the data, the new dataset failed to uphold the original conclusions and the authors have requested a retraction of the original manuscript to sustain the integrity of their findings.

This paper provided an overview of the international trade of live raptors and owls over a 40-year period using data from the CITES Trade Database. We focused on temporal trends in the number of species traded, key commercial import and export countries, top traded species and analysed key importer and exporter countries involved in the wild-caught and captive-bred trade. Due to an accidental error within our data analyses, the reported top importer and exporter countries provided in Table 4 are incorrect. After re-analysing the data, the top exporter countries for wild-caught raptors should

read Guinea, Mongolia, Russia, Uzbekistan and Pakistan. For wild-caught owls should read Togo, Uzbekistan, Peru, Russia and Guinea. Furthermore, the top captive-bred raptor exporter countries should read United Kingdom, Spain, Germany, Belgium and Russia. Finally, the top captive-bred owl exporter countries should read United Kingdom, Belgium, The Netherlands, Germany and Togo. We apologise to the readers, reviewers and editors of the journal and trust that this letter prevents the dissemination of unsound conclusions from our original publication.
